MINUTES

ON APRIL 4, 2022 THE MAYOR AND TOWN COUNCIL HELD THE REGULAR SCHEDULED MEETING AT THE TOWN HALL COMPLEX. PRESIDING OVER THE MEETING WAS MAYOR BILLY CHAVIS. ALSO PRESENT FOR THE MEETING WERE COUNCILPERSONS LEANNE TROUTMAN, CYNTHIA FULLER, DAVID BARBER AND GEORGE SUMMERSON. THE MEETING WAS CALLED TO ORDER BY MAYOR CHAVIS. MAYOR CHAVIS THEN READ THE ITEMS ON THE PROPOSED AGENDA. A MOTION WAS MADE BY COUNCILPERSON TROUTMAN TO APPROVE THE AGENDA AS READ. COUNCILPERSON FULLER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. COUNCILPERSON BARBER MADE A MOTION TO APPROVE THE MINUTES OF THE MARCH 7, 2022 MEETING. COUNCILPERSON TROUTMAN SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION.

THE **MEETING** THEN BEGAN BYCONDUCTING THE 2ND READING/ADOPTION OF ORDINANCE VIOLATION PENALTIES. COUNCILPERSON BARBER MADE A MOTION TO ADOPT THE ORDINANCE VIOLATION PENALTIES AS PRESENTED. COUNCILPERSON TROUTMAN SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION.

IN NEW BUSINESS, RICHARD TRULUCK OF SPATIAL ENGINEERING MADE A
PRESENTATION TO THE MAYOR AND COUNCIL OF THE GIS MAPPING
PROGRAM THAT HIS COMPANY PROVIDES. TRULUCK PROVIDED

INFORMATION HE BELIEVES WOULD BE VALUABLE TO THE TOWN. HE STATED THE GIS SERVICES THAT COULD BE PROVIDED WOULD INCLUDE LOCATIONS OF THE TOWN'S WATER LINES, MAIN CUT OFF LOCATIONS, AS WELL AS, LOCATIONS OF OTHER UTILITIES AND PROPERTY INFORMATION. UPON CONCLUSION OF MR. TRULUCK'S PRESENTATION, HE ASKED FOR ANY QUESTIONS OR COMMENTS FROM THE MAYOR AND COUNCIL. THERE WERE NONE AT THIS TIME. THE MAYOR THEN REQUESTED AN AMENDMENT TO THE CURRENT 2021-2022 BUDGET TO RELOCATE \$3,500.00 FROM THE LINE ITEM "PARKS AND RECREATION DIRECTOR" TO LINE ITEM "PURCHASE OF PARKS AND RECREATION EQUIPMENT". COUNCILPERSON FULLER MADE A MOTION TO ALLOW THE RELOCATION OF FUNDS. COUNCILPERSON SUMMERSON SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. JUDGE CHASITY AVINGER THEN SWORE IN NEW COMMITTEE MEMBERS FOR THE TOWN. MS. TIFFANY CASON WAS SWORN IN ON THE ELECTION COMMITTEE AND THE ZONING BOARD OF APPEALS. MS. JULIET HAM, MR. DAVID TEAGUE AND MR. JUSTIN VANBOGART WERE ALL SWORN IN ON THE PLANNING AND ZONING COMMITTEE.

IN THE ADMINISTRATION DEPARTMENT, TOWN CLERK PAM HYMAN REPORTED MAYOR CHAVIS WILL BE ATTENDING THE NEWLY ELECTED MAYORS CONFERENCE IN COLUMBIA ON WEDNESDAY APRIL 6. SHE STATED SHE WILL BE ATTENDING THE MCAA TRAINING IN COLUMBIA ON FRIDAY APRIL 8. SHE CONCLUDED BY ADVISING THE MAYOR AND

COUNCIL THAT SHE IS CURRENTLY WORKING WITH THE BANK TO BE ABLE TO OFFER DIRECT DEPOSIT FOR PAYROLL CHECKS.

IN PARKS AND RECREATION, COUNCILPERSON FULLER ADVISED THE TOWN DID NOT RECEIVE ANY BIDS FOR THE JOB TO REPAIR THE FLOORS AT GILMORE PARK SO THE REPAIRS ARE STILL NOT COMPLETED. MAYOR CHAVIS ADDED THE BASEBALL SEASON KICKS OFF TOMORROW NIGHT AT FOLK PARK AND ENCOURAGED EVERYONE TO PLEASE COME OUT AND SUPPORT THE CHILDREN. HE STATED THERE ARE 67 KIDS SIGNED UP FOR THE BASEBALL PROGRAM THIS YEAR.

IN THE AIRPORT DEPARTMENT, COUNCILPERSON SUMMERSON REPORTED ACCIDENT VICTIM FROM THE AIRPORT CRASH LAST MONTH IS STILL RECOVERING IN THE HOSPITAL AND THE SCENE HAS NOT YET BEEN CLEANED UP. HE HAD NOTHING FURTHER TO REPORT AT THIS TIME.

IN THE POLICE DEPARTMENT, CHIEF DETTER SHARED THE MONTHLY STATISTICS REPORT WITH THE MAYOR AND COUNCILMEMBERS. CHIEF DETTER ADVISED THE MAYOR AND COUNCIL THE DURANGOS SHOULD BE COMPLETED TOMORROW. HE THEN STATED HE IS STILL WORKING ON A GRANT FOR THE PURCHASE OF PICKUPS. CHIEF DETTER THEN ADVISED HE WILL BE ATTENDING THE POLICE CHIEF'S DAY AT SENATE TOMORROW.

IN PLANNING AND ZONING, MRS. DIANE BERGEN REPORTED THE MONTHLY MEETING WAS HELD ON MARCH 28, 2022. MRS. BERGEN REPORTED THE OWNER OF THE RUSTY TRUNK WAS ADVISED AT THAT MEETING THAT SIDEWALKS ARE SCDOT RIGHT OF WAY. MRS. SHARON

WADE THEN ADVISED THE CHAIR WILL BE ELECTED AT MONDAY'S MEETING. MS. GAYLE AUSTIN THEN ANNOUNCED SHE WILL BE ENFORCING BUSINESS LICENSE AND PERMIT REQUIREMENTS.

IN THE PUBLIC WORKS DEPARTMENT, COUNCILPERSON TROUTMAN REPORTED A LIFT STATION WIRE BROKE AND 2 AERATORS WERE DOWN. CAROLINA PUMP AND MOTOR COMPANY HAS COMPLETED THE REPAIRS. BEING NOTHING FUTHER ON THE AGENDA, THE FLOOR WAS OPENED FOR PUBLIC COMMENTS.

THERE WAS NO EXECUTIVE SESSION SCHEDULED FOR THIS MEETING.

BEING NO FURTHER BUSINESS TO DISCUSS, COUNCILPERSON FULLER

MADE A MOTION TO ADJOURN. COUNCILPERSON TROUTMAN SECONDED
