

## MINUTES

ON JUNE 10, 2022 AT 6:30 PM THE MAYOR AND TOWN COUNCIL HELD A SPECIAL CALLED MEETING AT THE TOWN HALL COMPLEX. THE PURPOSE OF THE MEETING WAS FOR A PUBLIC HEARING REGARDING THE ANNEXATION OF PROPERTY COMPRISED OF +/- 73.9 ACRES BOUNDED TO THE NORTH BY BUNCH FORD ROAD AND EUTAW ROAD TO THE EAST AND IDENTIFIED AT TMS: 0332-12-01-026.000 IN ACCORDANCE WITH THE PROVISIONS OS TITLE 5, CHAPTER 3 OF THE CODE OF LAWS OF SOUTH CAROLINA 1976, AS AMENDED. ALSO, A PUBLIC HEARING REGARDING AN AMENDMENT TO THE ZONING MAP IN ACCORDANCE WITH THE PROVISIONS OF TITLE 6, CHAPTER 29, ARTICLE 5 OF THE CODE OF LAWS OF SOUTH CAROLINA, AS AMENDED. PRESIDING OVER THE HEARING WAS MAYOR BILLY CHAVIS. ALSO PRESENT FOR THE HEARING WERE COUNCILPERSONS LEANNE TROUTMAN, CYNTHIA FULLER AND DAVID BARBER. THE HEARING WAS CALLED TO ORDER BY MAYOR CHAVIS.

THE FLOOR WAS OPENED FOR PUBLIC COMMENTS REGARDING THE TWO HEARINGS. (SIGN IN SHEET ATTACHED) THERE WERE NO COMMENTS IN FAVOR OR OPPOSITION. MR. GEORGE BROOKS SIGNED UP FOR COMMENTS BUT HAD NONE ONCE CALLED UPON. AT THIS TIME, THE PUBLIC HEARING WAS ADJOURNED IN ORDER TO BEGIN THE SPECIAL CALLED COUNCIL MEETING'S AGENDA ITEMS.

MAYOR CHAVIS CALLED THE MEETING TO ORDER AND BEGAN BY PROVIDING THE INVOCATION. MAYOR CHAVIS THEN READ THE PROPOSED

AGENDA ITEMS. COUNCILPERSON FULLER MADE A MOTION TO ACCEPT THE AGENDA AS READ. COUNCILPERSON BARBER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. TOWN CLERK PAM HYMAN THEN CONDUCTED THE 2ND READING OF AN ORDINANCE REGARDING ANNEXATION OF PROPERTY COMPRISED OF +/- 73.9 ACRES BOUNDED TO THE NORTH BY BUNCH FORD ROAD AND EUTAW ROAD TO THE EAST AND IDENTIFIED AT TMS: 0332-12-01-026.000 IN ACCORDANCE WITH THE PROVISIONS OS TITLE 5, CHAPTER 3 OF THE CODE OF LAWS OF SOUTH CAROLINA 1976, AS AMENDED. COUNCILPERSON BARBER MADE A MOTION TO APPROVE THE ANNEXATION OF THE PROPERTY. COUNCILPERSON FULLER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. IN CONTINUING, TOWN CLERK PAM HYMAN CONDUCTED THE 1ST READING OF AN ORDINANCE FOR THE TOWN OF HOLLY HILL TO ENTER INTO AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES WITH AMERICAN ENGINEERING CONSULTANTS, INC. COUNCILPERSON FULLER MADE A MOTION TO APPROVE THE ORDINANCE AS READ. COUNCILPERSON BARBER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. BEING NOTHING FURTHER TO DISCUSS, COUNCILPERSON BARBER MADE A MOTION TO ADJOURN. COUNCILPERSON TROUTMAN SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION AND THE MEETING ADJOURNED.
