

## MINUTES

ON AUGUST 8, 2022 AT 6:30 PM THE MAYOR AND TOWN COUNCIL HELD A SPECIAL CALLED MEETING AT THE TOWN HALL COMPLEX. THE PURPOSE OF THE MEETING WAS FOR A PUBLIC HEARING REGARDING A PROPOSED AMENDMENT TO THE TOWN OF HOLLY HILL ZONING MAP AS IT RELATES TO TMS: 0339-13-01-003.000 OWNED BY HUNLEYTOWN, LLC.; AND OTHER MATTERS RELATED THERETO. PRESIDING OVER THE HEARING WAS MAYOR BILLY CHAVIS. ALSO PRESENT FOR THE HEARING WERE COUNCILPERSONS LEANNE TROUTMAN, CYNTHIA FULLER, GEORGE SUMMERSON AND DAVID BARBER. THE HEARING WAS CALLED TO ORDER BY MAYOR CHAVIS.

THE FLOOR WAS OPENED FOR PUBLIC COMMENTS REGARDING THE PROPOSED AMENDMENT (SIGN IN SHEET ATTACHED). THERE WERE NO COMMENTS IN FAVOR OR OPPOSITION. NO ONE SIGNED UP FOR COMMENTS. AT THIS TIME, THE PUBLIC HEARING WAS ADJOURNED IN ORDER TO BEGIN THE SPECIAL CALLED COUNCIL MEETING'S AGENDA ITEMS.

MAYOR CHAVIS CALLED THE MEETING TO ORDER AND BEGAN BY PROVIDING THE INVOCATION. MAYOR CHAVIS THEN READ THE PROPOSED AGENDA ITEMS ADDING AN AMENDMENT TO THE AGENDA IN WHICH ITEMS #2 AND #3 UNDER "NEW BUSINESS" WOULD BE CHANGED IN ORDER SO THAT #3 WOULD BECOME #2 AND #2 WOULD BECOME #3. COUNCILPERSON TROUTMAN MADE A MOTION TO ACCEPT THE AGENDA

WITH THE AMENDMENT NOTED. COUNCILPERSON FULLER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION.

TOWN CLERK PAM HYMAN THEN CONDUCTED THE 2ND READING OF A PETITION FOR ANNEXATION OF TMS: 0339-13-01-003.000 OWNED BY HUNLEYTOWN, LLC; AND OTHER MATTERS RELATED THERETO. COUNCILPERSON BARBER MADE A MOTION TO APPROVE THE PETITION FOR ANNEXATION OF TMS: 0339-13-01-003.000 OWNED BY HUNLEYTOWN, LLC. COUNCILPERSON SUMMERSON SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION.

IN NEW BUSINESS, COUNCILPERSON TROUTMAN MADE A MOTION TO ADOPT THE RESOLUTION AUTHORIZING THE TOWN OF HOLLY HILL TO APPLY TO THE USDA RURAL DEVELOPMENT FOR FUNDING AND EVIDENCING SUPPORT FOR THE PURCHASE OF TWO NEW POLICE VEHICLES THAT WAS DISCUSSED AT THE EARLIER PUBLIC HEARING. COUNCILPERSON FULLER SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. CLERK HYMAN THEN CONDUCTED THE 1ST READING OF A PETITION FOR ANNEXATION OF TMS: 0332-12-02-004.000 (APPROX. 35,481 ACRES LOCATED ALONG EUTAW ROAD) OWNED BY STAHL, LLC; AND OTHER MATTERS RELATED THERETO. COUNCILPERSON BARBER MADE A MOTION TO ACCEPT THE PETITION. COUNCILPERSON TROUTMAN SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION. THEN CLERK HYMAN CONDUCTED THE 1ST READING OF A PETITION FOR ANNEXATION OF TMS: 0339-00-02-009.000 (APPROX. 104.21 ACRES LOCATED

ALONG EUTAW ROAD) OWNED BY C. MCCURRY, M. MEDLEY, J. PUSSER, R. RHAME, JR., V. SINGLETARY, C. HORGER, II, R. HORGER AND C. WANNAMAKER; AND OTHER MATTERS RELATED THERETO. COUNCILPERSON TROUTMAN MADE A MOTION TO ACCEPT THE PETITION. COUNCILPERSON SUMMERSON SECONDED THE MOTION. ALL VOTED IN FAVOR OF THE MOTION.

IN THE POLICE DEPARTMENT, CHIEF DETTER JUST WANTED TO THANK THE MAYOR AND COUNCIL FOR THEIR SUPPORT FOR THE GRANT.

NO OTHER DEPARTMENTS HAD ANYTHING TO REPORT AT THIS TIME.
