MINUTES

ON SEPTEMBER 11, 2023, AT 6:30PM THE MAYOR AND TOWN COUNCIL HELD THIER REGULAR SCHEDULED MEETING AT THE TOWN HALL COMPLEX. PRESIDING OVER THE MEETING WAS MAYOR BILLY CHAVIS. ALSO, PRESENT FOR THE MEETING WAS COUNCILPERSONS CYNTHIA FULLER, LEANNE TROUTMAN, GEORGE SUMMERSON. MAYOR CHAVIS CALLED THE MEETING TO ORDER AND BEGAN PROVIDING THE INVOCATION. MAYOR CHAVIS THEN READ THE PROPOSED AGENDA ITEMS. COUNCILPERSON TROUTMAN MADE A MOTION TO ACCEPT THE AGENDA AS READ. COUNCILPERSON FULLER SECONCED THE MOTION.ALL VOTED IN FAVOR OF MOTION. COUNCILPERSON FULLER THEN MADE A MOTION TO APPROVE THE MINUTES OF THE AUGUST 28, 2023, MEETING. COUNCILPERSON SUMMERSON SECONDED TEH MOTION. ALL IN FAVOR OF MOTION.

TO BEGIN THE MEETING MAYOR CHAVIS INTRODUCED BOBBY MONROE FROM HDL COMPANIES TO DO A PRESENTATION ON HDL COMPANIES AND WHAT THEY OFFER FOR BUSINESS LICENSES ENHANCEMENT. MR BOBBY MONROE STATED HDL A CALIFORNIA CORPORATON IS AUTHORIZED TO OBTAIN BUSINESS LICENSE, PERMITS AND APPROVALS AS MAY BE REQUIRED BY LAW FOR PERFORMING SERVICES FOR THE TOWN OF HOLLY HILL. HDL OPERATES IN 650 DIFFERENT STATES TO DISCOVER BUSINESS THAT DO NOT HAVE A TOWN LICENSE FOR SMALL TOWNS TO RECIEVE REVENUE FOR COMPANIES. HDL IS A 50/50 REVENUE FOR THE FIRST 2 YEARS AND WILL NOT RECEIVE FUNDS UNTIL THE TOWN OF HOLLY HILL RECIEVES FUNDS FROM THE BUSINESS THEAT ARE MADE TO RECIEVE A LICENSE FOR THE TOWN OF HOLLY HILL.

COUNCILPERSON TROUTMAN ASKED IF HDL COMPANY RECOMMENDS DIFFERENT VENDORS THAT DELIVER TO LOCAL STORES (EXAMPLE (BREAD, SODA, CHIPS) TO APPLY FOR A BUSINESS LICENSE. COUNCILPERSON FULLER HAD QUESTIONS AND CONCERNS ABOUT THE 50/50 CONTRACT WHEREAS HDL DOES NOT RECIEVE ANY FUNDS UNTIL THE TOWN OF HOLLY HILL DOES SO THROUGH COMPANIES THAT PURCHASE BUSINESS LICENSE.

A RESLOUTION WAS READ FOR TOWN OF HOLLY HILL TO APPROVE THE AGREEMENT FOR THE CONSULTANT SERVICES WITH HDL SERVICES. COUNCILPERSON TROUTMAN MADE A MOTION TO ACCEPT. COUCILPERSIN SUMMERSON SECONDED THE MOTION. ALL IN FAVOR OF THE MOTION.

TOWN CLERK SHELIA WILLIAMS CONDUCTED THE 2ND READING ORDINANCE TO AMEND THE BUSINESS LICENSE ORDINANCE OF THE TOWN OF HOLLY HILL TO UPDATE THE RATES. COUCILPERSON FULLER MADE A MOTION TO ACCEPT THE ORDINANCE. COUNCILPERSON TROUTMAN SECONDED THE MOTION. ALL IN FAVOR OF THE MOTION.

TOWN CLERK SHELIA WILLIAMS CONDUCTED THE 2^{ND} READING OF THE ORDINANCE FOR THE TOWN OF HOLLY HILL TO REGULATE THE USE OF CERTAIN VEHICLES/AIRCRAFTS AT HOLLY HILL AIRPORT; AND OTHER MATTERS REALTED THERETO. COUNCILPERSON FULLER MADE A MOTION

TO ACCEPT. COUCILPERSON TROUTMAN SECONDED THE MOTION. ALL IN FAVOR OF THE MOTION.

AT THIS TIME MAYOR CHAVIS INTRODUCED TIFFANY PROVENCE AS THE NEW JUDGE FOR THE TOWN OF HOLLY HILL MUNICIPALITY COURT COUNCILPERSON TROUTMAN MADE A MOTION TO ACCEPT. COUNCILPERSON SUMMERSON SECONDED THE MOTION. ALL IN FAVOR OF THE MOTION, JUDGE MUCKENFUSS SWORN IN JUDGE TIFFANY PROVENCE.
