**SET-UP: You may begin setting up as early as 8:00 a.m. on Saturday (must be ready to begin by 10 a.m.)**

**Electricity will not be available to non-profit vendors. You must provide your own extension cords, adaptors, and generator.**

As a Particpate of the Holly Hill Christmas Festival, I agree to:

1. Be responsible for any damages to Town property due to my participation in the festival. No Steel spikes in the asphalt or sidewalks.
2. Leave my site clean and litter free.
3. Be responsible for all federal, state, and local licenses required.

- 4. Set up my display so as to leave space for the passage of pedestrians, wheelchairs, and other equipment for people with disabilities.
  - 5. No use of or allow use of tobacco or alcoholic beverages on the Town's public property.
  - 6. No Sale of illegal or dangerous items including those items that are vulgar or obscene.
